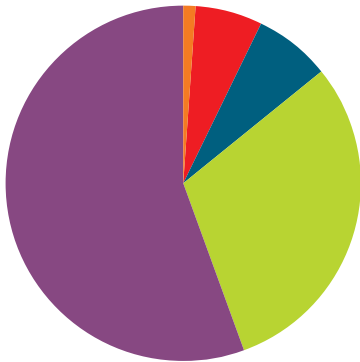

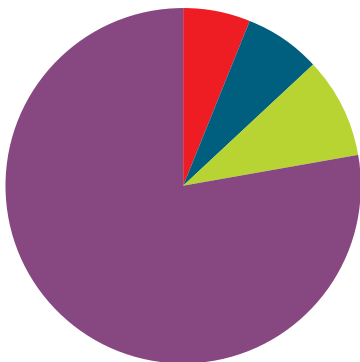


2015 FINANCIAL REPORT
